All open/unpaid invoices with the Stewartville Area Chamber of Commerce need to be paid in full by June 21st in order to be in our parade. Line up numbers will be assigned and emailed 1 week prior to the parade and will be spaced according to safety for all. We are excited to have you part of our parade!

Waiver Agreement:

You, referred to here after as Parade Entrant, agree to make no claim for any reason whatsoever, including negligence, against the Stewartville Area Chamber of Commerce and their officers, members and/or parade volunteers, the Stewartville School District-ISD #534, the City of Stewartville and/or their officers and employees for loss, theft, damage or destruction of property, nor for any injury or accident involving you, your parade entry, and/or persons involved with your parade entry.

Parade Entrant also agrees to indemnify and hold harmless the Stewartville Area Chamber of Commerce and their officers, members and/or parade volunteers, the Stewartville School District-ISD #534, and the City of Stewartville and/or their employees from and against all cost, attorney's fees, expenses, or liabilities resulting from any such claim, action, or proceeding brought thereon.

Parade Entrant is responsible for any damages they cause to the Stewartville School District-ISD #534 grounds, parking lots and facilities. Parade entrant will be responsible and billed for such damage with the dollar amount determined by the Stewartville School District-ISD #534.
